- V. Staff Reports
 - a. Clergy
 - i. Life cycle events are continuing in the appropriate and safe manner
 - ii. Clergy team continues to reach out to congregants on a weekly basis with positive feedback on our programming and events
 - b. Executive Director
 - i. Cemetery Plots Update
 1. The update is in the Board report and contains that we've secured a new area as well as the expenditure for additional plots that should last about 3 yrs
 - ii. Security Fee: \$72 – Bill on February 1, 2021
 1. This will be added to the February billing statement, there will be verbiage about how these funds will be used.
 - iii. Fence Update
 1. There will be a meeting with the agency to determine the full requirements for the fencing and its crash ratings.

- a. The issue is the level of crash rating that's needed to qualify for the funding. The full crash rating would require an additional expenditure of about \$150-200K
 - b. The additional expenditure may require a congregational vote
 - iv. Casualty Insurance Meeting
 - v. Check Signor changes reflective in the minutes: Resolution
 - 1. Motion: Fred Leviton: To change the check signors for the bank accounts: removing Larry Jacobson and Frank Urman, adding Lisa Thorner and Dave Eisner

 - c. Religious School Update
 - i. Fees
 - 1. We should review our fee structure and how we can make changes that meet the changing requirements of families
 - ii. The goal of having more in-person classes has not materialized as its meeting the needs of the community (as well as local school districts starting more in-person sessions).
 - d. Preschool Update
 - i. Tuition increase for 2021-22: 3%
 - ii. Before and Aftercare: .50 cent per hour increase
 - e. Programming
 - i. Purim – events are planned to include fundraising and classes

- VI. Committee Reports
 - a. Budget
 - i. The report the first six months of the fiscal year
 - ii. The membership dues and collections were a focus. This included all families and their payment histories and finding ways to keep all members in the Sinai family
 - 1. We may need to look to forming a committee and look at “what is a member, what are our dues structures, etc.”
 - 2. The deficit still remains at the \$600K level, there are sufficient cash reserves.
 - b. PPP Certification
 - i. Motion: Vicki Goldman: This board resolution dated 1/26/21, is to certify Temple Sinai's financial necessity to apply for a second round of PPP funding due to the financial uncertainty surrounding the ongoing effects of COVID19 on the Temple's operations. Temple Sinai is facing a projected \$660,000 deficit for the fiscal year ending 6/30/21. This deficit is due to the Temple's inability hold the annual fundraiser, uncertainty relating to the collection of dues and donations, and the significant decline in preschool revenues. Temple Sinai's

regular operations do not provide adequate cashflow to service debt.
Therefore, borrowing money from banks, is not an option. (Steve Weinstein)

d. Audio/Video Update

e. Caring Committee – Sharon Sloane

- i. There are about 20 volunteers on this committee making phone calls to temple members, birthday cards/greetings, birthday kits to kids, and additional ways to reach out to members. This group will take on a new member ambassador role.

f. Lifelong Jewish Learning – Marty Meitus

- i. Marty outlined several programs but highlighted the significant impact that Facebook has made in getting significantly higher attendance for activities/events
 - 1. This has also allowed us to increase the type and variety of speakers and where they broadcast from. Being on-site is no longer a requirement due to adaptation of Zoom.

g. Temple Sinai launched a YouTube channel

- i. We are now able to simulcast our streaming on to Facebook and YouTube

h. Social Tzedek – Kathy Zeiger/Rabbi Callman

- i. This is the basis for our social action activity under this umbrella. The goal is find a “focus” issue, which will be food injustice/food inequality
 - 1. We’ll look to determine projects that could combine across all ages and groups within the community

i. JCRC

- i. The JCRC are looking for votes on several items, and need an update/vote from Temple Sinai by 2/4/21
 - 1. The motions are in the board packet for review.
